**Kris Wagner** at 1523 Oakleaf Drive in Auburn. Mr. Wagner stated that he has been living here 17 years and parking his work truck at his residence. Said all of a sudden Code Enforcement is telling him he needs to move it. Mr. Wagner said that he restores and retains internet and is on-call. Said that just yesterday after the storms he got home at 4pm and got called back out 4-5 hours later. Stated that stuff like that is why he needs his truck at his house at all times. Said his employer needs for him to have his truck at his house at all times. Stated that he would have to move if the City didn't allow this to happen. Mr. Wagner said the SUP that he had been told to fill out, that all of the questions were not applicable to him. That it pertained to parking a truck in the driveway. Said he did not know what else to say. Said 17 years I have lived here and had no problems and now all of a sudden. He said let me add that I have worked in 15 States. I have been doing this work for 23 years and no matter where I have stayed that truck has been with me. Now I finally find a house. I just got it paid off last year and now I am going to have to move because of this commercial vehicle parking. I wish ya'll would allow me to continue to park here.
