Jay Miller presented the case to discuss amending the code of ordinances for the Downtown Overlay District to add single-family detached as a permitted use. Jack Wilson provided additional details on the amendment. Josh Edmonds asked if there was any opposition to the amendment. There was none. Josh Edmonds entertained a motion to recommend ordinance to revise list of permitted uses as follows: 17.91.042(15) - Dwellings, *renovation and reconstruction of existing single family detached, new single detached construction on existing single family lots*, single-family attached, multifamily, and residential over commercial.
